### **General information**

### Reading and storing the manual



This user manual accompanies the Walking Pad (hereafter referred to as the "product"), and contains important inormation on assembly and use.

Before using the product, read the user manual carefully. This particularly applies to the safety instructions. Failure to do so may result in personal injury or damage to the product.

Store the user manual for further use. Make sure to include this user manual when passing the product on to third parties.

#### Proper use

The product is intended exclusively as an indoor training device. It is only intended for private, domestic use and not suitable for commercial purposes.

Only use the product as described in this user manual. Any other use is considered improper and may result in damage to property or persons.

The manufacturer or vendor cannot be held liable for damages or injury incurred through improper or incorrect use.

# IMPORTANT SAFETY INSTRUCTIONS

When using an electrical appliance, basic precautions should always be followed, including the following:

Read all instructions before using this product.

DANGER - To reduce the risk of electric shock:

 Always unplug the product from the electrical outlet immediately after using and before cleaning.

# WARNING – To reduce the risk of burns, fire, electric shock or injury to persons:

- The product should never be left unattended when plugged in. Unplug from the outlet when not in use and before putting on or taking off parts.
- Do not operate under blanket or pillow. Excessive heating can occur and cause fire, electric shock, or injury to persons.

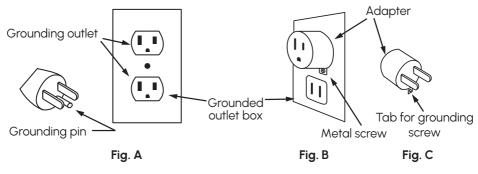

#### **Grounding instructions**

- This product must be grounded. If it should malfunction or breakdown, grounding provides a path of least resistance for electric current to reduce the risk of electric shock. This product is equipped with a cord having an equipmentgrounding conductor and a grounding plug. The plug must be plugged into an appropriate outlet that is properly installed and grounded in accordance with all local codes and ordinances.
- DANGER Improper connection of the equipment-grounding conductor can result in a risk of electric shock.
   Check with a qualified electrician or serviceperson if you are in doubt as to whether the product is properly grounded.
   Do not modify the plug provided with the product if it will not fit the outlet, have a proper outlet installed by a qualified electrician.
- This product is for use on a nominal 120-V circuit, and has a grounding plug that looks like the plug illustrated in Fig. A. A temporary adapter that looks like the adapter illustrated in Fig. B and C may be used to connect this plug to a 2-pole receptacle as shown in Fig. B if a properly grounded outlet is not available. The temporary adapter should be used only until a properly grounded outlet (Fig. A) can be installed by a qualified electrician. The green colored rigid ear, lug, or the like extending from the adapter must be connected to a permanent ground such as a properly grounded outlet box cover. Whenever the adapter is used, it must be held in place by a metal screw.





#### Risk of injury!

Improper handling of the product may result in injury.

- Only connect the product if the line voltage of the outlet corresponds to the data on the rating plate.
- Always wear suitable sports shoes when using the product.
   Do not run bare foot as it may cause injuries.
- Wear tight fitting clothes to prevent clothes from being caught by the product.
- Consider your physical condition when you start to train with the product. Train appropriately and regularly to ensure that you have enough physical strength for training.
- The product is intended for indoor use only. It is not intended for professional training, testing or medical purposes.
- Check all parts of the product before each use to ensure that screws and nuts are tightened.
- Place the product on smooth and level ground. Make sure there are no sharp objects near the product.

- Do not touch any moving parts with hands. Do not place your hands and feet in the space under the walking belt.
- The product is designed for use by one person only.
- The maximum weight capacity is 198 lb (90 kg). Do not exceed the maximum weight capacity.
- Keep lubricating oil out of reach of children. If ingested or got into eyes, rinse with clean water and seek medical attention immediately.
- Do not use the product if it is deformed or broken.
- Make sure there is vacant area (free of obstacles) measuring 78 × 40 inch (200 × 100 cm) behind the product.
- If you notice any abnormalities during your workout, immediately grab onto the handrails and pull yourself up to keep your feet off the walking belt. Then, carefully jump out of the product to avoid potential hazards.
- If you experience dizziness, chest pain, nausea or shortness of breath during exercise, stop immediately and seek medical advice



#### Health hazard, risk of leakage and explosion!

Improper handling of the batteries may result in health hazard, leakage or explosion.

### Before you begin

### Unpacking



#### Risk of damage!

Improper handling of the product may result in damage.

- Do not open the packaging with a sharp knife or other pointed object to avoid damage.
- Unpack the product at the location where you intend to use it. This will make the setup process smoother.
- 2. Take all the parts out of the packaging and place them on the floor.
- 3. Check to make sure that all parts are included (see chapter "Product contents/parts").
- 4. Check whether the product or individual parts are damaged. If this is the case, do not use the product. Contact the after sales service.

### Choosing the setup location

#### Installation location

 Always install the product on a flat and stable surface, with good ventilation and close to a power source. The product must be used indoors.

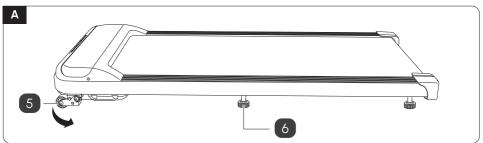
#### **Electrical considerations**

- The product should be connected to a 110–120 V, 15 A outlet (power rating of most household outlets in North America).
- For the best results and safety, plug the product directly into the outlet rather than
  using extension cords. In case an extension cord is needed, use a 12 AWG cord with a
  single plug end, rather than a multi-tap option, to ensure stable and efficient operation.

## Setup

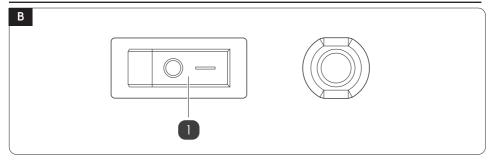
### Step 1: Adjusting the inclination

If desired, the inclination of the product can be adjusted to increase the intensity of your workout.



- 1. Pull the front wheels 5 downwards (see Fig. A).
- 2. Rotate the adjustable foot pads 6 to adjust their height. Make sure they are in touch with the ground surface (see Fig. A).

### **Step 2: Connecting for power**



- 1. Connect the plug of the power cord to a properly installed power outlet.
- 2. Press the power switch 1 to set it to the ON (1) position (see Fig. B).

### **Operation**



#### Warm-up and cool-down exercises

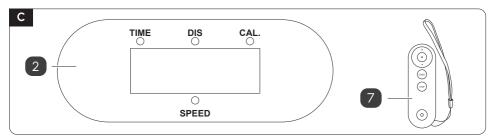
A successful workout plan includes warm-up, aerobic and cool-down exercises. Warm-up exercises are crucial and must be done before each workout to warm up the body, stretch the muscles and adapt to higher intensity exercises. Repeating warm-up exercises at the end of the workout can relieve muscle soreness.

- Head movement: Stretch the head to the right shoulder, then left shoulder, rotate clockwise and then counterclockwise.
- Shoulder exercise: Lift left shoulder and rotate backwards, then repeat with the right shoulder
- Stretching exercise: Grab the right wrist with the left hand and pull upwards. Then switch to the left wrist.
- Quadriceps stretching: Stand with the right hand against a wall, lift the left foot towards buttocks and hold for 15 seconds. Then switch to the left foot.
- · Inner thigh stretching: Sit with feet soles together and pull towards the body. Press down on heels and hold for 15 seconds
- Achilles tendon stretching: Sit and push the left foot inward towards the body. Then switch to the right foot.
- Calf stretching: Stand with both hands against a wall and lift each foot backward alternately.

The internet is an invaluable source of information for details of the above exercises.

## **Operation**

### Operating the product



Use the remote control 7 and display 2 to operate the product (see Fig. C).

The remote control may require pairing with the product when using for the first time. To do so, press and hold the START button on the remote control for around 7 seconds until the product emits a continuous buzz sound.

- + button / button: Increases or decreases speed.
- M button: Cycles among 4 operating modes (speed, time countdown, distance countdown and calorie countdown).
- START button: Turns on the product.
- STOP button: Turns off the product.
- TIME display: Shows walking time in manual mode.
- SPEED display: Shows current walking speed.
- DIS. display: Shows accumulated distance in manual mode.
- CAL display: Shows accumulated calories burned during workout in manual mode.



#### Risk of damage!

Improper handling of the product may result in damage to the product.

- Do not use any aggressive cleaners, brushes with metal or nylon bristles, or sharp or metallic cleaning utensils, such as knives, hard scrapers and the like. They could damage the surfaces
- Make sure that no water or other liquids penetrate the housing. Never immerse the product in water or other liquids.

### Cleaning

- 1. Unplug the product and allow it to cool off completely.
- 2. Use a damp cloth to wipe off the product. Then let all parts dry completely.

### Inserting or replacing the battery

The remote control requires one CR2025, 3 V === button cell battery. If the remote control is not responsive or not working, the battery power may be low or empty. Replace the battery.

- 1. Turn the remote control 7 over.
- 2. At the bottom of the remote control, pull the battery tray out from the remote control.
- 3. Insert a battery into the battery tray. Make sure the polarity is correct (the "+" side faces upwards).
- If you are replacing the battery, take the old battery out of the battery tray before
  inserting the new one. Dispose of the old battery in accordance with the applicable
  regulations (see chapter "Disposing of the product").
- 4. Slide the battery tray back into the remote control until it locks into place.

#### **Maintenance**



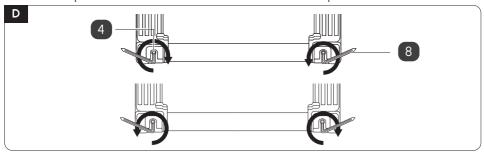
**INFO** 

To prolong the lifespan of the product:

- Let the product rest for 10 minutes after continuous use of 1 hour.
- Wear clean sports shoes when exercising to avoid dust and debris.
- Regularly check for wear and damage and replace the defective parts immediately.
- All servicing should be performed by a professional repair center. Contact customer service for servicing. There are no serviceable parts inside the product.

#### Walking belt adjustment for deviation

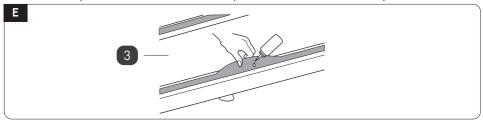
1. Place the product on a flat surface and set it to walk at a speed of 3 km/h.



- 2. Make adjustment accordingly:
- If the walking belt deviates to the left: Use the Allen wrench (8) to rotate the left adjustable screw (4) clockwise by 180°; and rotate the right adjustable screw counterclockwise by 180° (see upper part in Fig. D).
- If the walking belt deviates to the right: Use the Allen wrench to rotate the right adjustable screw clockwise by 180°; and rotate the left adjustable screw counterclockwise by 180° (see lower part in Fig. D).

#### Lubricating the walking belt

Light users (less than 2 hours per week) should lubricate the walking belt every 6 months, whereas heavy users (more than 5–7 hours per week) should do so every 2–3 months.



- Lift the edge of the walking belt 3 upwards and apply silicone oil under the walking belt (see Fig. E).

### **Storage**

#### General storage

All parts must be completely dry before being stored.

- Always store the product in a dry area.
- Protect the product from direct sunlight.
- Store the product so that it is not accessible to children.

### **Troubleshooting**

Problem	Possible cause	Solution
The product does not work.	The power connection is not properly done or the power outlet is defective.	Make sure the power cord is properly connected to the power outlet and the power outlet is not defective.
	The battery power of the remote control is low or empty.	Replace the battery (see chapter "Inserting or replacing the battery").
Error code El or E2	Internal error	Unplug the product and restart again. If the problem persists, contact the after sales service.

Problem	Possible cause	Solution
Error code E5	Overcurrent protection is activated	<ul> <li>Unplug the product and restart again.</li> <li>Lubricate the walking belt.</li> <li>Make sure the product is not overloaded (198 lb/90 kg).</li> <li>If the problem persists, contact the after sales service.</li> </ul>
Error code E6	Voltage problem	Make sure the voltage of the power outlet is correct. Unplug the product and restart again. If the problem persists, contact the after sales service.

This warranty covers the following components and aspects of the gym equipment:

- · Structural integrity of the frame, including welds and construction.
- · Mechanical parts, such as cables, pulleys, bearings, and weight stacks.
- · Electronic components, including control panels, sensors, and displays.
- · Upholstery and padding, excluding normal wear and tear.
- · Functional performance of the equipment, including movement and range of motion.
- This warranty is valid only for the original purchaser of the gym equipment and is non-transferable.

The warranty is limited to repair or replacement of parts, at our discretion, and does not cover any other expenses such as transportation costs, installation, or labor charges.

In the event that a particular component or aspect is no longer available or has been discontinued, Ascend reserves the right to provide an equivalent replacement or alternative solution.

#### **Exclusions:**

- If necessary, Ascend may arrange for an authorized representative to inspect the equipment or request the return of the defective part or product for further evaluation.
- · Upon review and confirmation of a valid warranty claim, Ascend will, at its option:

If arbitration is not agreed upon or if a provision of this warranty is determined to be unenforceable, the parties agree that any legal action or proceeding arising out of or relating to this warranty shall be brought in the courts of the province of Quebec, and each party hereby submits to the exclusive jurisdiction of such courts.
